<b>14:30-15:40</b> <i>Geopolitics and the Enlargement of the EU</i>	<b>A brave new EU: Rethinking the (geo)politics of enlargement</b> The tectonic shift in global geopolitics caused by the Russian invasion of Ukraine has irrevocably linked the security architecture of the European Union (EU) to the question of the Union's enlargement. This policy has proven ineffective in the Western Balkans, raising questions as to its credibility for integrating the Eastern Partnership countries, including Ukraine. How can the EU become politically, institutionally, and financially prepared for 30+ members? What will such a Union look like, and what place will the current aspiring members have in it? In this panel, we discuss the modalities in which the EU's enlargement policy can be reformed to best balance the challenge of the new geopolitical reality against the internal need for institutional reform and democratic legitimacy. We propose avenues through which the Union could have a greater impact on the transformation of (potential) candidate countries locked in protracted political and economic transitions. The latest research by Bertelsmann Stiftung on the EU economy comes to a surprising conclusion: Less-developed, rural regions in the EU could gain significantly in economic prosperity from a transition to renewable energy, while urban areas with high energy demands could face setbacks. In short, it's well worth it for rural regions to pursue a renewable energy overhaul although their support is currently rather limited, while urban areas with high support for green policies could face future financial and political hurdles due to rising costs and political "greenlash." This panel will grapple with the implications of these findings for policymakers, businesses and consumers and address questions like:

- How can policymakers ensure buy-in from rural regions by highlighting these benefits? And what can be done to forestall waning support for green energy policies in urban areas?
- How can rural and urban regions work together to leverage the strengths of each to meet the needs of the other? What can be done to end up with a mutually beneficiary outcome?
- What synergies can be leveraged between the EU's cohesion policy and energy policy? Can cohesion policy support energy policy goals?

#### The internal market and the EU green deal: Friends or foes?

#### Third time lucky? Prospects for the *Spitzenkandidaten* process for the 2024 European Elections

The purpose of the proposed roundtable is to discuss the impact of the *Spitzenkandidaten* process and debate its prospects for the 2024 European elections, bringing together a number of scholars including some of the editors and contributors of the recently published volume on the topic. The *Spitzenkandidaten* process can be seen as a major innovation in the EU's political system and has arguably revolutionised the manner in which the top leadership in the EU is selected. system has helped to make EU politics more transparent and responsive to citizen interests, whether it is misguided or indeed whether, as some have claimed, actually has failed. **Are we out of the woods? The new economic policy mix**

This panel will discuss post-inflation crisis economic scenarios from a global and European perspective and reconsider the challenges that these poses to economic policy in Europe. Managing high levels of debt, financing the many “transitions” and the post-war reconstruction(s), and strengthening resilience to tail risk, will require a reconsideration of the mode in which different policy institutions interact, in guaranteeing sustainable growth, stability and inclusiveness. How can Europe improve its capacity to prevent such scenario, while creating the macroeconomic and financial premise for an efficient redirection of its high-quality resources towards innovative sectors and exploit the full potential of the single market?

### **War, human rights, and double standards**

The European Union's response to Russia's full-scale invasion of Ukraine was seen as determined and united. Accordingly, European member states pulled together to offer temporary protection to millions of Ukrainians displaced by the conflict. European institutions organised and coordinated unprecedented sanctions. European people experienced a profound energy crisis and began an equally profound energy transition. And, at least up to the end of 2023, all levels of governments worked to help support Ukraine with both humanitarian and military assistance in that country's efforts to resist and repel Russian aggression. Within Europe, this showunder of solidarity was cause for celebration in most seats of power. Outside Europe, however, the reception was very different. Many voices expressed dismay at the economic and humanitarian consequences of a prolonged conflict. Many also questioned why European responses to Ukraine were so different from European responses to other conflicts and refugee flows. Hamas' attack on the South of Israel and the Israeli government's response in Gaza only deepened concern about European commitment to the protection of human rights, and about its double standards and racialised politics, both within and outside Europe. Such concerns are not easily dismissed. They chip away at European self-perception of civilian power or normative power even as they threaten to undermine Europe's relations with other countries and its role in a changing world order. The challenge for European leaders is to explain such a gap in perception and action and ultimately the connection between European policy and European proclaimed values.

### **Resilient economies and institutions to mitigate and adapt to climate change**

### **New modes of European Macroeconomic Governance**

New forms of European macroeconomic governance The European Union has reinvented macroeconomic governance over the past fifteen years – by rewriting the rules for fiscal policy coordination, creating new institutions for macroeconomic and financial stabilization, and, through Next Generation EU, developing a new pattern for promoting country-specific reforms by tying them to common European projects backed by common European resources. The result is an unprecedented form of cross-border macroeconomic policy coordination that does not look like a ‘federation’ but is certainly much more than exists in any international organization. The purpose of this panel is to take stock of the current arrangement – which is based to a large extent on instruments that are either officially ‘temporary’ or that have yet to be tested – and to explore what it tells us about the nature and direction of European integration.

#### **Blurring Lines: Foreign interference and local proxies**

This panel, jointly organised by the European Media and Information Fund (EMIF) and the European Institute for Security Studies (EUISS)-led Countering Foreign Interference (CFI) project, will discuss foreign interference in Europe, and the role that local proxies play in supporting and amplifying their harmful effects.

The central focus of the panel is the interplay between state-backed foreign information manipulation and interference (FIMI); the EU member states and partner countries that they target; and local proxies (such as paramilitary organisations, local political actors and media outlets, mercenary groups, etc) within these states. These local proxies have been known to further amplify and disseminate manipulated narratives within their networks. Moreover, based on relevant research, the European Parliament’s ING2 Special Committee on foreign interference in all democratic processes in the European Union, including disinformation, has pointed out these issues as highly problematic and in need of urgent attention. In the context of the upcoming European elections, held shortly after this event, FIMI threats are particularly salient and even more acutely relevant to address as effectively as possible leveraging existing tools or developing new measures.

### **Rethinking capitalism in Europe in the path to sustainability**

Does the transition require a deeper transformation of the existing economic model and of the underlying social contract? If so, what are the main obstacles for this shift of paradigm in Europe? How does the inherent interconnection and competitiveness of the global economy affect and influence the EU space of action? Bringing together academics, practitioners and policymakers, this panel will explore innovations, challenges and contradictions of EU policy on redressing capitalism.

**Building Ukraine back better**

The 'reconstruction' of Ukraine in response to Russia's brutal war of aggression began on the second day of the conflict and will continue for the foreseeable future. What was immediately obvious is that the challenge for policymakers – and for the Ukrainian people – goes far beyond reconstruction. They have to prepare Ukraine for a future within the European Union and in the context of a more hostile and competitive global environment. To face this challenge, they will need to help restore Ukrainian society as they rebuild and modernize the country's infrastructure, industry, political institutions, and social services. ### Investing in the Mediterranean neighborhood as part of EU's new geopolitical context

The wars in Ukraine and Israel require the EU to redefine its geopolitical orientation, also from an industrial perspective. A key element is its policy towards its neighborhood, not least in the Mediterranean. Such a review may comprise more infrastructure investments and a strengthening of the industrial cooperation on the climate and energy transition as well as on the digital economy. Important legislation on these issues has been finalized by the Von der Leyen commission, but important implementation issues remain to be solved. Huge investments are necessary and new cooperation opportunities arise in the form of new pipelines for gas and hydrogen (or derivatives), massive availability of renewable energy (solar, wind), need for more electricity transmission lines, etc. Will the EIB raise the stakes of triggering these investments? Does the Commission have an integrated plan?

**Blockchain regulation: By rules or enforcement?**

The development of Digital Assets based on blockchain technology has contributed to economic growth and increased the efficiency of financial systems around the world.
